About the seminar

Mediation is a process by which the parties to a dispute are assisted by an independent third party, the mediator, to resolve their dispute. One of the fundamental distinctions of this approach is that the parties retain control over the process and in particular settlement of the dispute. This can be contrasted with arbitration or court proceedings, where the appointed third party determines the dispute and imposes a settlement on the parties.

The importance of mediation in resolving construction dispute is increasing quickly. Not only that it becomes part of the dispute resolution mechanism under the new private standard form, the Hong Kong Court also actively promotes the use of mediation through the introduction of Practice Direction 31 early this year.

In this seminar, two leading practitioners will share their practical knowledge and experience in construction mediation. It is particularly suitable for those who engage in construction contract administration or those who wish to expand their professional practice and become an architect-mediator.
