 - ◆ **Social Health Insurance (Tax-like Model)**
 - All working population contribute 3-5% income for whole population’s Social health insurance fund.
 - ◆ **Out-of-Pocket Payments (User-pays Model)**
 - Increase user fees for using public healthcare services.
 - ◆ **Medical Savings Accounts (User-pays Model)**
 - Specified working population deposit 3-5% income for future healthcare expenses especially after retirement.
 - ◆ **Voluntary Health Insurance (Individual Health Insurance Model)**
 - Encourages public to purchase private health insurance.
 - ◆ **Mandatory Health Insurance (Individual Health Insurance Model)**
 - Specified working population purchase (3-5% income) standardized insurance regulated by the Government before retirement.
 - ◆ **Personal Healthcare Reserve (Individual Health Insurance Model)**
 - Specified working population deposit 3-5% income for government-regulated insurance before & after retirement.
