#### Academic Qualification Assessment Guidelines

Under Rule <u>1.3 (b)</u> of the *HKIA/ARB Professional Assessment Handbook*, a graduate from a non-HKIA/ARB accredited or recognised school of architecture may apply for an Academic Qualification Assessment if he/she wishes to sit for the Professional Assessment to become an HKIA Member and a Registered Architect. Guidelines for the AQA are set out as follows :

## 1) Eligibility

The applicant shall be the holder of a 5-year full-time or equivalent <u>professional programme</u> in architecture from a tertiary school of national standing. The Professional Assessment Committee (PAC) shall have the final decision as to the acceptance or otherwise of the professional degree.

# 2) Application

The applicant should make his/her application to the PAC via the HKIA/ARB Secretariat. The application should be accompanied by the following materials:

- Application letter addressed to the Chair of PAC.
- Curriculum vitae, complete with the applicant's personal information and academic history. (*Annex 1*)
- A copy of the applicant's HKID Card/ Passport.
- A recent photograph of the applicant.
- A copy of the applicant's degree/ diploma certificate.
- Transcript issued by the school/ university concerned, in English or Chinese, giving details of all the academic subjects taken and grades achieved by the applicant in the year of his/her graduation.
- Letter confirming validity of the academic qualification, issued by the school/ university. (*Annex 2*)
- Portfolio of the applicant's works leading up to the professional degree, particularly thesis design project, and other dissertations carried out in the year of graduation, showing the curriculum strength of the programme and the outcomes acquired in the programme. Verification on the authenticity of his/ her portfolio should be submitted.
- Declaration of the applicant regarding the authenticity of the submitted portfolio, specifying the extent of his/ her involvement in the projects as individual / group work. (Annex 3)
- Proof of proficiency in English as equivalent to HKDSE English Language Level 3.

# 3) Assessment

Upon the receipt of *all* the materials specified above, the PAC Chair shall convene an AQA Panel to determine if the qualification will be accepted as meeting/ matching a standard equivalent to that of an HKIA/ARB accredited or recognised professional degree programme. The Panel shall consist of the following three HKIA members:

- Chair of the Panel, who shall be an HKIA Member nominated by the PAC Chair.
- Two members, who shall be an HKIA Member and a senior teaching staff from local universities/ tertiary institutions offering HKIA/ARB accredited architectural programmes, appointed by the PAC and approved by the Head of Department of Architecture of the respective universities/ tertiary institutions.

The Panel shall meet to carry out the AQA. The Chair and the Members shall each have an equal vote in deciding on the results of the AQA, and the recommendation of the Panel shall be submitted to PAC for endorsement and that the decision shall be notified to the applicant by the Secretariat. At the discretion of the Panel, the applicant may be asked to attend an interview. The decision of PAC shall be final.

# 4) <u>AQA Fee</u>

The fee to be charged to the applicant, for any single assessment, shall be \$6,000.00, payable in advance.
