Important points to note:

1. Only candidates who have successfully enrolled in the Professional Assessment (PA) 2024 Paper 3, 4 and 5 are eligible to join the above PA lectures, no registration is required. The lecture fee has been included in the Paper fee of PA 2024 Papers 3, 4 and 5.
2. For attended candidates on the lecture day who are Graduate Member of HKIA, 2 CPD hours for each lecture will be granted.
