- Streamlined the meeting format and approval process of the board business to make the board meetings more efficient.

There are some aspects which I have to admit that I could have done better as the BP Chair. They are for example:

- SPOL, adjudication and fee diving issues. The Task Force for Architectural Services to specially look at these issues was set up in the 2<sup>nd</sup> year of the term. Actions could have been taken more in advance if the TF was set up earlier.
- Forums with different Bands of practices. Breakfast meetings were set up in the 2<sup>nd</sup> year of the term and were welcome by many firms. Such dialogue could have been established earlier so that the Board could hear more and do more.

The reasons for me to continue to run for a council member at the new term are:

- In the past 1.5 year, I feel that the Institute was more diversely represented; actions taken were more transparent and our eyes were laid on a boarder spectrum.

I treasure these changes and want to continue my effort in up keeping this culture.
