President's Report

Thank you for attending the Second Quarterly General Meeting (QGM) of The Hong Kong Institute of Architects (HKIA) in 2022.

With the subsiding of the fifth wave of COVID-19 Omicron, HKIA is gradually returning to normal operation. The Institute shall continue to do its best to provide needed services and support to our members and the profession.

Before my reporting on works done by the Institute, I would like to announce on behalf of the Council that Mr. Watson Chan, who joined the HKIA Secretariat as Deputy Chief Operating Officer on 2 February 2022, has been officially appointed as Chief Operating Officer, commencing 4 May 2022. As introduced at the March Quarterly General Meeting, Watson is a veteran senior executive with profound experience in policy research and association management. We are glad to have Watson taking a leadership role in building a stronger Secretariat team to serve HKIA.

Ensuring our Voices are Heard

Letter to Chief Executive-elect

We look forward to the starting of a new chapter by the sixth term HKSAR Administration. With the "result-oriented and solution-driven approach" adopted by the Chief Executive-to-be, I, on behalf of the Institute, submitted a proposal to Mr. John Lee for building a better Hong Kong through promoting a sustainable and resilient city design, pursuing architectural excellence, and constructing a more liveable and vibrant future with our members' professional expertise.

Mr. John Lee has replied and indicated that he would look forward to working with HKIA in building a more liveable and vibrant Hong Kong in the years to come.

Liaison with Government and allied organisations

We have been in close liaison with various government departments and allied organisations on different topics for the good of the profession and construction industry.:

- Our views on Optimising the Environmental Impact Assessment Ordinance Process were submitted to the Environment Bureau.
- Our views on Streamlining Development-related Statutory Processes were submitted to the Development Bureau. A consultation session was held with the Development Bureau to exchange views on the legislative proposal.
- Our views on Revitalizing Historic Buildings through Partnership Scheme and Financial Assistance for Maintenance Scheme on Built Heritage were submitted to the Commissioner for Heritage's Office.
- Our views on Preserving the Bishop Hill Underground Cistern and other heritage sites were submitted to Water Supplies Department, after a meeting with the Director of Water Supplies Department.

Expanding our representation

The Institute is expanding our representation at various consultation committees and organizations to enhance our professional influence in the community. We've nominated representatives to multiple external and government organisations for timely and constructive inputs to tackle various issues:

- Mr. Lam Wo Hei will represent the Institute at *Technical Committee on Plumbing of Water Supplies Department* for the coming 3 years.
- Mr. Chiu Hon Hang will represent the Institute at the *Fire Safety Committee* and *Advisory Committee for the Fire Safety (Buildings) Ordinance and Fire Safety (Commercial Premises) Ordinance* for the coming 3 years.
- Mr. Ho Lik Chi Nicholas will represent the Institute at the *Board of Review (Inland Revenue Ordinance)* from 2023 to 2025.
- We also have extensive representation at the Construction Industry Council (CIC):
 - Mr. Chan Hui Man Truman will continue representing the Institute at the Taskforce on Design for Safety for the coming year.
 - Mr. Lo Chun Wai Dicky will represent the Institute at the Committee on Construction Business Development for the coming 2 years
 - Mr. Ho Lik Chi Nicholas and Mr. Franklin Yu will represent the Institute at the Committee on Productivity for 2 years
 - Mr. Leung Man Kit will represent the Institute at the Committee on Environment for 2 years.
 - Mr. Chan Chung Yee Albert and Mr. Chan Chak Bun will represent the Institute

at the Committee on Construction Safety for 2 years.

Upholding Professional Standards

Unreasonable fee issue

The Institute is aware of the fee diving fee issue in the industry. We have communicated with various parties on this undesirable situation which is harmful to our profession. We notice that small improvements have been achieved with the recent adoption of the fee-diving control mechanism by the Government.

HKIA/ARB Professional Assessment

Under the receding COVID-19 pandemic environment, the Professional Assessment is the first Institute project to resume physical format, in order not to interrupt the career path of our prospective architects.

The Professional Interview will be held this Saturday on 11 Jun. A total of some 200 eligible candidates will take part in this final stage to be registered architects. Thanks to the Young Members Committee, an online session was held on 26 May to share members' experience and ease candidates' stress in coping with this important examination. May I wish all candidates come out with flying colours.

Written examinations will be held in Jul and Nov as scheduled. Additional sessions of Papers 3, 4 & 5 would be arranged for compensation of the cancelled sessions originally scheduled for Mar 2022, and helping our prospective members to get licensed.

Revalidation of architectural curricula of local tertiary institutions

The Institute is busy with works of revalidation and interim review of architectural courses provided by 4 local tertiary institutions this year. The revalidation process is of utmost importance to ensure a smooth path of nurturing architects for the profession. We shall keep members posted of the results once the revalidation visits and reports are completed.

Support to members in the Mainland

The Institute is also eager to provide support to members in the Mainland. A series of forums were held in the first two quarters to keep our members updated with the

most recent legislations and opportunities in the Mainland. We are also in close liaison with relevant authorities to organise accredited CPD courses for members to maintain their PRC Class 1 Registered Architect Qualification.

HKIA 65th Anniversary Celebration – Architecture for People

Projects of the 65th Anniversary are gradually unveiling with the stabilizing pandemic situation. And we are appealing for your participation.

HKIA 65th Exhibition, Gala Dinner and Commemorative Publication

HKIA Annual Awards 2021

May I congratulate all the winning teams of the HKIA Annual Awards 2021 one more time. After one-and-a-half-month assessment, the 4-member jury panel decided to award 6 projects with 7 awards. Prize Presentation was held on 20 May 2022 at HKIA Premises. We were honoured to have our Juror representative Mr. John Tsang and HKIA Gold Medal 2021 recipient Prof. Patrick Lau to present the Annual Awards, together with Young Architect Award and Student Medal to the recipients. An exhibition showcasing all the awarded and finalist entries, as well as winning entries of Young Architect Award and Student Medals were held at the Central Market in end May. 2 public workshops on producing lightbox of Hong Kong's skyline were organized and attended by over 80 participants. The Institute received an overwhelming response on the awarded projects, the exhibition and the workshops. I would like to express my heartfelt thanks to the Jury Panel, composed of Mr. John Tsang, Prof. He Jianxiang, Prof. David Tseng and Ms. Irene Cheng, the Annual Awards 2021 a great success.
