### **Deed of Constitution**



Annual Report 2000

WE, THE UNDERSIGNED being met together on the third day of September in the year one thousand nine hundred and fifty-six and being desirous of forming a Society in the Colony of Hong Kong for the general advancement of Civil Architecture and for promoting and facilitating the acquirement of the knowledge of the various Arts and Sciences connected therewith DO HEREBY BAND OURSELVES TOGETHER IN A SOCIETY TO BE KNOWN AS THE HONG KONG SOCIETY OF ARCHITECTS and do undertake as Foundation Members to subscribe to the funds and be bound by the Rules of the Society AND DO FURTHER DECLARE AND AGREE AS FOLLOWS:

- 1. that the Society shall consist of Members, Honorary Members, Associates, Graduates and Students;
- 2. that the Society shall elect and be governed by a Council consisting of a President, two Vice-Presidents, and such other Officers and Members of Council as it may decide:
- that the Society shall make such Rules for its own good governance and the conduct of its members as it may from time to time think fit;
- that the Society shall have power in its corporate name to acquire, hold and dispose of property and funds and shall to this end comply with Ordinances of the Government of Hong Kong;
- 5. that the Society shall invite and have as its Patron a person of eminence in colony.

### **Historical Note**

#### **FORMATION**

On 3rd September, 1956, 27 architects gathered and formed a Society "for the general advancement of Civil Architecture and for promoting and facilitating the acquirement of the knowledge of the various Arts and Sciences." Thus The Hong Kong Society of Architects was formed. On 7th May, 1957, the first amendments were made, to stand for over two and a half years. During this period the membership of the Society increased by 50% and recognition as an Allied Society was given by Royal Institute of British Architects. In accord with this growth further amendments were made to come into effect on 3rd November, 1959. By the end of 1962, the Society expanded to a membership seven times as large as that first body of foundation members.

The changes of name from Society to Institute was effected in 1972 after a great deal of preparatory work, and has initiated a new phase of activity in the Institute's affairs. Members will use the professional affix - Architect IIKIA and describe themselves as Member of The Hong Kong Institute of Architects. Associates will describe themselves as Associate of The Hong Kong Institute of Architects in full. No abbreviation of this is permitted.

#### **PURPOSE**

The two main purposes of the Institute are to continue to raise both the standard of architecture in Hong Kong and the standard of professional services offered by its members.

### **CODE OF PROFESSIONAL CONDUCT**

In addition to the responsibilities of architects as professionals under law, members of the Institute are governed by a Code of Professional Conduct. This Code aims to provide the standard of professional conduct and self-discipline required of the members of the Institute in the interest of the general public.

#### DISCIPLINE

A member whose conduct is found to be in contravention of the Code or dishonouring the principle of the Code is liable to reprimand, suspension or expulsion. This ensures that the public receives from HKIA members only the highest standard of professional service.

#### SERVICE TO THE PUBLIC

The Institute also serves the public by applying the collective expertise of its members in an advisory role to government and to the building industry. Today, HKIA is represented in numerous consultative or advisory bodies ranging from a working group which counsels the drafting of new building and planning legislation to a committee which formulates standard contracts for use in the building industry.

#### ARCHITECTURAL EDUCATION

In the field of education, the Institute works closely with the two Universities, namely, the University of Hong Kong and the Chinese University of Hong Kong and offers courses and counsel in professional practice and practical experience in architecture.

#### PROFESSIONAL QUALIFICATION

Every year, candidates aspiring to the professional qualification of Architect sit a professional examination held by the Institute. Successful candidates receive recognition not only from professional bodies in Hong Kong but also in UK. Australia, Canada, USA and other countries.

#### INTERNATIONAL PARTICIPATION

In recent years, the Institute takes Hong Kong to the fore in international circles through its active participation in the International Union of Architects (UIA), the Commonwealth Association of Architects (CAA), and the Architects Regional Council of Asia (ARCASIA).

#### **ORGANIZATION**

Today, The Hong Kong Institute of Architects has more than 1500 full members and over 300 associate members and graduate members. The Institute is governed by a Council formed by a President, two Vice-Presidents, an Honorary Secretary, an Honorary Treasurer and 13 Council members. The Council appoints 4 Boards, each charged by a member of the Council, to deal with specific areas in the objectives of the Institute. They are the Board of Internal Affairs, the Board of Overseas Affairs, the Board of Educational Affairs and the Board of Local Affairs. These Boards in turn appoint committees to deal with matters within the area of responsibility of the Boards.

### Report from The President

It was a singular honour to be President as the HKIA entered the new millennium. Through the hard and dedicated work of the Council, the Committees and all the representatives and through the encouragement and support of the members the past year has seen an enormous amount of ground covered.

In January 2000 the HKIA held an International Conference on Improving Quality of Building Design with particular emphasis on the procurement process. Much work has continued on, particularly, the tendering processes carried out by governmental agencies and the Institute is pressuring these agencies to improve the current systems. A major fault of the present approaches to tendering is a lack of comprehension by the client bodies on the nature of architectural services and the confusion of a product versus a professional service.

The early part of the year saw a successful completion of the HKIA Annual Awards 1999 with Anthony Ng Architects Limited being awarded the Silver Medal for Tung Chung Crescent Development. Three Certificates of Merit were awarded to Rocco Design Limited in association with Arup Associates. (Hong Kong Station and Development Phase 1), CYS Associates Limited (The Hong Kong Academy of Medicine Jockey Club Building) and Anthony Ng Architects Limited in association with the Architectural Services Department (Tsing Yi Complex). The President's Prize was awarded to the Architectural Services Department for their Health Education Exhibition and Resources Centre in Kowloon Park. We wish to thank the Jurors for their excellent work in this difficult task, particularly Professor Chung Yung Ho from China (for Annual Awards 1999) and Professor Nobuo Hozumi from Japan (for Annual Awards 2000).

In January 2000, as representative of the HKIA, I was involved in the Hong Kong Tourist Association's Study on Improvement and Further Development of the Peak as a Visitor Attraction and this report has now been submitted to the government for consideration. Throughout the year the Institute has been involved in the Promotion of Construction Services both with the Works Bureau and with the Hong Kong Trade Development Council. As prime instigators of these initiatives the HKIA is playing a leading role in the promotion of architectural services in our export markets.

The HKIA has been working with the Housing Bureau on a number of projects including the proposed bill on the Sale of Uncompleted Residential Properties and on future directions for the provision of public housing in Hong Kong. Throughout the year the HKIA has interacted with the Hong Kong Housing Authority and I attended workshops, conferences, discussions and forums on housing matters on behalf of the Institute. The Institute is not in agreement with the current methods of tendering for architectural services, undertaken by the Hong Kong Housing Authority and the dialogue is continuing to find an acceptable alternative.

February saw the Inaugurating Forum "A Step Forward towards a Greener Hong Kong" at the Hong Kong Convention and Exhibition Centre at which the Building Authority Mr. C. M. Leung announced his wide ranging green initiatives. This programme continued throughout the year and culminated in the Green Tour to Germany and the Netherlands which was very well attended by Members. A new board was proposed to support Members Practices and this has now been established by the current Council.

A conscious effort was made to engage government departments related to the architecture field and to this end visits were made to Works Bureau, Electrical & Mechanical Services Department and Water Services Department, the Geotechnical Engineering Office, the Planning Department, Lands Department, Environmental & Food and Hygiene Department and Transport Department amongst many others. The HKIA was deeply involved with the Green Island Reclamation, the Aberdeen Fish Market Redevelopment, Tung Chung North New Town, Lei Yue Mun Redevelopment and Tai O initiatives for planning. The latter resulted in a very successful weekend workshop and the HKIA has been encouraged by the Government to take an active role in this important reconstruction project.

April saw more than 60 participants undertake an adventurous study trip to India and



participants visited New Delhi, Agra, Chandigarh and the Rajasthan State of Northern India. Local chapters of the I.I.A. were met throughout the tour and the whole exercise was judged an outstanding success. In the same month the Department of Architecture, The Chinese University of Hong Kong was visited by the HKIA/ARB Accreditation Board and after a thorough vetting the Department was given accreditation for the next 5 years.

On going throughout the year was a dialogue with the Construction Industry Review Committee but the Institute was not satisfied with the composition of the committee particularly as there was no Architect/Authorized Person on the main body. The findings of the committee have yet to be implemented and we will wait to see how effective they will be. The whole of the construction industry was shaken with the 'short-pile' problems but this is but one aspect of a major changes in the whole of the production of the built environment. There was much talk about "partnering" but little progress was made on risk assessment and risk assignment which is the key underlying problem.

This year the Institute was heavily involved in organizing architectural competitions. The first to be successfully completed was the Vehicle Pound for the Hong Kong Police. This was followed by the Country Park Shelters for the Agriculture, Fisheries & Conservation Department with the major competition being the Centre for Youth Development for the Home Affairs Bureau. The start on the Housing Competition was made and this has now been completed.

I was fortunate in being able to attend on behalf of the HKIA a number conferences and seminars both in Hong Kong and aboard and I presented papers at a number of them. During my term of office I have made every effort to work with the Architectural Society of China in joint projects and I was honoured to be invited to attend their Annual General Meeting in Beijing in November. I also held meetings with Professor Li Xian-kiu, Director General of International Relation, Ministry of Construction on his trip to Hong Kong.

An on-going project was that associated with Schools and the HKIA held workshops, children competitions and educative programmes all through the year. This close co-operation with the Education and Manpower Bureau generated workshops on School Design and the School Improvement Programme. The emphasis the Council placed on community outreach exercises such as these allowed a large number of members to participate in community related projects thus exemplifying the relevance the profession has to the society as a whole. This area of work is an important adjunct to the normal activities for member services and it is continuing under your new President.

The meetings of the Ten Professional Bodies carried on throughout the year with the end product being the opening of a Joint Professional Centre in The Centre at the beginning of this year. The close cooperation with parallel professions has resulted in many meetings with the government and the Chief Executive stressing the important role the professionals play in the overall success of the community.

I wish to take this opportunity to thank all the Council Members, Board Chairman, Board Members and participants for their unstinting support throughout my two years as President. This constant response made the time pass all too quickly and many of the initiatives started will need an ongoing commitment on the part of many members. Finally without the back up of the Secretariat and the Registrar, the President could not operate and I offer particular thanks to them for their help. It has been a great pleasure and a honour to serve as President of the HKIA and I wish Patrick every success in his term of office.


#### **HKIA Examination**

#### Paper 4 Professional Interview

The Professional Interview was held on 25 February 2000. The rigorous full-day exercise was made possible by the contribution from 36 senior HKIA Members & Fellows, forming 11 interviewing panels to examine 91 candidates. The passing rate for Professional Interview is 79%.

#### **Passing Rates**

The conclusion of the 1999 Examination saw the offer of admission to 72 new HKIA Members, representing an overall passing rate of 32%. Detailed passing rates of individual examination papers are as follows:

#### Seminar on "The New PRC Contract Law and Bidding Law: Impacts on Mainland **Building Projects**"

Mr Chan's talk focused on crucial legal aspects relating to the new PRC Contract Law (effective 1 October 1999) and the new PRC Bidding Law (effective 1 January 2000).

Prof Patrick Lau gave a talk on "The Architectural Profession" on 26 February in the Careers Seminar series of the Expo. The event enabled the Institute to reach out on students, parents and the general public on architectural education and the architectural profession.

#### VI GREENING 2000

An Inaugural Forum held on 21 February 2000 at Hong Kong Convention & Exhibition Centre was successfully concluded. Some 150 people attended the Forum. A site visit to Cathay Pacific City at Chek Lap Kok held on 11 March 2000 was arranged. Some 50 members attended the visit.

The sub-committee was also organizing a series of seminars, forums, design competition, workshops and study tours relating to sustainable architecture in Year 2000.

### VII ARCASIA Council Meeting & 9th Asian Congress of Architects (ACA-9)

Same as previous years, the ARCASIA is organizing a Council Meeting and ACA-9 to be held during 5-9 September 2000 in Kuala Lumpur, Malaysia. The HKIA delegation is being formed for particupation.

#### **VIII CAA Activities**

CAA Council Meeting and the General Assembly would be held during 2-8 April 2000 in Wellington, New Zealand. Mr Chung Wah Nan and Mr Tony Wong will attend the Council Meeting as CAA Vice President of Asia Region and Official Delegate for HKIA respectively.

Concurrently, an exhibition on Historic Building would be held during the General Assembly. Architectural Services Department and the University of Hong Kong will be making submission for this Exhibition.

#### IX Conference on "A Quality Agenda for Consultant Selection"

The Conference held on 26-27 January 2000 at Hong Kong Scout Association was successfully completed. Mr Michael Peck of RAIA and Mr John Wright of RIBA were both invited to be keynote speakers for the Conference. Other speakers including Mr Barry Will of HKIA, Mr Russell Black of MTR Corporation, Mr Keith G Kerr of Swire Properties Ltd, Mr Victor So Hing Woh, JP of the Hong Kong Housing Society, Mr Pau Shiu Hung of Architectural Services Department and Mr John Anthony Miller of Housing Department were invited to speak at the Conference. About 120 participants attended the Conference.

The opening ceremony of the exhibition shall be held on 3 April and prize presentation of both Annual Awards and Young Architect Award shall be made at the ceremony.


### 2ND QUARTERLY GENERAL MEETING Hon Secretary Report, 21 June 2000

#### HKIA Professional Visit

#### a. Academic Exchange Excursion to India, 21-28 April 2000

A delegation of 57 members with their families headed by the President Mr Barry Will, the AEC Chairman Mr Leung Hon Ming and the Chairlady of Overseas Excursion Organizing Committee Ms Josie Dee made an excursion to Delhi, Agra, Jaipur and Chandigarh during 21-28 April 2000. Apart from sightseeing and visiting historical monuments and government buildings, the HKIA delegates also made courtesy visits to Chandigarh College of Architecture, Mr J R Bhalla's Office, and had fruitful discussion with Northern Chapter, Chandigarh-Harvana-Punjab Chapter of Indian Institute of Architects.





Some members from the Heritage and Conservation Committee made a visit to Taiwan on 11-13 May 2000 with an objective to learn about the local conservation.

The Site Safety Training Committee, chaired by Mr Bernard Hui, organised a series of Basic Course on April 8, 11, 18; May 9, 23; and June 14. A total of 242 Members, Graduate Members and supporting staff of HKIA member practices attended those sessions. The first CEPD Seminar on Site Safety Training held on 14 June was attended by some 35 members. The Basic Course and the CEPD Seminar was made possible by the contributions from the Institute's own Site Safety Trainers and representatives from the Labour Department.

#### XVI Members' Activities

#### a. Dragon Boat Team

#### Registration for Examination

At the close of registration on 5 August 2000, a total of 296 applications have been received, of which 164 were from fresh candidates and 132 from resitting candidates. Vetting of these applications is in progress.

#### Second Professional Interview

A Second Professional Interview was held on 29 August 2000 for the 19 candidates who failed the Interview in February 2000. A total of 13 candidates passed, representing a passing rate of 68.4%.

#### **Question Papers**

Subject Panels are in the process of reviewing past questions and setting new questions. The possibility of establishing a systematic question pool for each subject is being explored.

#### Paper 3 Case Study

At the time of reporting, the Case Study examination was well underway. A total of 135 submissions of Case Study Synopsis were received and are being perused by the Paper 3 Subject Panel. The approved Synopsis will be returned to candidates in late September to facilitate their preparation of the full Case Study report for submission on 29 December 2000.

### I HKIA/ARB Professional Examination System

Subsequent to the endorsement by HKIA Council and the Architects Registration Board of the Revised Professional Examination System proposed by the HKIA/ARB Examination Working Committee, the Examination Committee had reviewed the system and the formulation of the implementation details was underway.

#### II HKIA Examination 2000

During the period under review, the work of the Examination Committee in preparation for Examination 2000 is outlined as follows:

#### Lecture & Seminar Series

The 21-session Lecture & Seminar Series, which began in mid-August ended on 2 November 2000. This year, a total of 117 Candidates attended the 52.5-hour Series, which covered the major subject areas for the HKIA Examination.

#### Question Papers - Moderation, Vetting & Review

Rigorous preparation had been carried out by the Subject Panels under the Examination Committee during September to early-December in setting examination questions for the Examination. The draft questions were reviewed by an Hong Kong Examinations Authority's Moderator in late October.

An Internal Vetting Panel comprised of an HKIA Vice President, the ARB Chairman, the BEA Chairman and Exam Committee Chairman was set up in October. Two rounds of Internal Vetting meetings were held in early & late November to review all examination papers.














#### Paper 3 Case Study

#### NOTES TO THE FINANCIAL STATEMENTS

#### 1. Activities and operations

The Institute is registered under the Hong Kong Institute of Architects Incorporation Ordinance for the general advancement of Civil Architecture and for promoting and facilitating the acquisition of the knowledge of the various Arts and Sciences connected therewith. Principal activities include the holding of meetings, lectures, examinations, exhibitions, competitions and similar activities.

### 2. Summary of significant accounting policies

#### (a) Basis of accounting

The financial statements have been prepared in accordance with generally accepted accounting principles in Hong Kong and under the historical cost basis of accounting.

#### (b) Principles of consolidation

The consolidated financial statements for the year ended 30 September 2000 include the accounts of the Institute and its wholly-owned subsidiaries, HKIA Services Limited and Star Creation Development Limited. Both companies are incorporated in Hong Kong.

HKIA Services Limited owns the land and building acquired during 1985 (Note 6) which is occupied by the Institute up to 31 July 1997 and thereafter was re-classified to investment property on 1 August 1997. Star Creation Development Limited was incorporated on 20 March 2000 but has not commenced business.

It is intended to be engaged in internet trading.

Intercompany balances and transactions have been eliminated on consolidation,

#### (c) Depreciation

Depreciation is calculated to write off the cost or valuation of property, furniture and equipment over their useful lives on the straight-line basis, at the following annual rates:-

Investment property NIL
Furniture and equipment 25%
Office computer 25%
Leasehold improvements 20%

#### (d) Inventory

Inventory consists mainly of standard contract forms, Standard Form of Building Contract, Form of Tender which are stated at the lower of cost or net realisable value. Cost includes direct costs of purchases and incidental costs in bringing the inventory to their present location and condition. Net realisable value is based on anticipated selling price less all further costs to be incurred prior to sale.

#### (e) Taxation

The Institute has been granted exemption from Hong Kong Profits Tax by the Inland Revenue Department for its prior years, excess of income over expenditure. The Council believes that similar exemptions will continue to be granted accordingly no provision for Profits Tax has been made.

The Institute's subsidiary, HKIA Services Limited, has provided for Hong Kong profits tax at the rate of 16% on the estimated assessable profit for the year.

No provision has been made for the Institute's other subsidiary, Star Creation Development Limited, as it has not commenced business during the year.

#### (f) Investment property

Investment property represents leasehold land and building held in Hong Kong under a long term lease. The company has adopted the recommendations of Statement of Standard Accounting Practice No 13 issued by the Hong Kong Society of Accountants whereby investment properties are not depreciated.

#### (g) Related party

A party is considered to be related if one party has the ability, directly or indirectly, to control the other party or exercise significant influence over the other party in making financial and operating decisions. Party is also considered to be related if it is subject to common control or common significant influence.

#### 3. Revenue recognition

#### (a) Members' entrance and subscription fees

Members' entrance and subscription fees are credited to income in the year of receipt. Annual subscription fees are taken up on an accrual basis.

#### (b) Lecture and examination fees

Lecture and examination fees are recognised when the lecture and the examination are held.

#### (c) Publications and advertisements

Revenue from sales of publications and advertisement is recognised when the publications are sold and the advertisements are published.

#### (d) Exhibitions and other functions


Revenue from exhibitions and other functions are recognised when the functions are held.
